

Business visas of RK «B1», «B2» and «B3»

Visa of RK of the **«B1»** category is issued to the following persons:

- 1) participants of conferences, symposiums, forums, exhibitions, concerts, cultural, scientific and other events;
- 2) participants of meetings, organizations of round tables, exhibitions, meetings of experts;
- 3) persons accompanying humanitarian aid;
- 4) persons arriving for the purpose of giving lectures and conducting classes in educational institutions;
- 5) participants of youth, student and school exchange programs, except for training in educational institutions of the Republic of Kazakhstan;
- 6) participants of sports events.

To apply for an **«B1»** visa, it is necessary to provide:

- 1) foreign passport (valid for at least 3 months from the date of visa expiration, at least 2 free pages in the passport);
- 2) completed and signed application form with one current photo (3,5x4,5);
- 3) a copy of the invitation from the Republic of Kazakhstan with number of visa support of the Ministry of internal Affairs of RK.
- 4) document confirming payment of the consular fee in the amount of:
 - single entry – 80 Swiss francs;
 - multiple visa – 200 Swiss francs.

Visa of RK of the **«B2»** category is issued to the following persons:

- 1) persons arriving for the purpose of installation, repair and maintenance of equipment;
- 2) persons arriving for the purpose of providing consulting or audit services.

To apply for an **«B2»** visa, it is necessary to provide:

- 1) foreign passport (valid for at least 3 months from the date of visa expiration, at least 2 free pages in the passport);
- 2) completed and signed application form with one current photo (3,5x4,5);
- 3) a copy of the invitation from the Republic of Kazakhstan with number of visa support of the Ministry of internal Affairs of RK.
- 4) document confirming payment of the consular fee in the amount of:
 - single entry – 80 Swiss francs;
 - multiple visa – 200 Swiss francs.

Visa of RK of the **«B3»** category is issued to the following persons:

- 1) persons arriving to conduct negotiations, conclude contracts;
- 2) persons arriving to conduct negotiations, conclude contracts in the framework of cooperation in the field of industrialization and investment;
- 3) founders or members of the Board of Directors.

To apply for an **«B3»** visa, it is necessary to provide:

- 1) foreign passport (valid for at least 3 months from the date of visa expiration, at least 2 free pages in the passport);
- 2) completed and signed application form with one current photo (3,5x4,5);
- 3) a copy of the invitation from the Republic of Kazakhstan with number of visa support of the Ministry of internal Affairs of RK.
- 4) document confirming payment of the consular fee in the amount of:
 - single entry – 80 Swiss francs;
 - multiple visa – 200 Swiss francs.
