Decree of the First President of the Republic of Kazakhstan Nursultan Nazarbayev on “Concept of the Republic of Kazakhstan in a field of Official Development Assistance” adopted on 9 April 2013



Law of the Republic of Kazakhstan “On Official Development Assistance” adopted on 10 December 2014



Decree “On Main Directions of State Policy in a field of ODA for 2017-2020 adopted on 31 January 2017



Kazakhstan Agency for International Development established on 15 December 2020



ODA Strategy Draft (Decree on the Main Directions of State Policy in a field of ODA for 2021-2025) to be adopted in 2021

Assistance and contribution of Kazakhstan in solving regional and global problems to promote sustainable development through ODA sectoral priorities:

1. agriculture and food security;
2. climate change, environment protection
3. assistance in solving transboundary water problems
4. healthcare, education, poverty reduction
5. the problems of international crime, illegal drug trafficking and illegal migration

Facilitate to our partner countries on their efforts to develop efficient and effective digital initiatives that enhance security, economic prosperity, transparent and open public governance, e-government, supporting entrepreneurship and improving the business climate

International cooperation on co-financing and joint implementation of projects, institutional support and sharing of knowledge and practice can be developed with foreign governments, international organizations
